March 15, 2018 for all artisans

### Jury Fee:

\$20 per applicant, per medium

Returning and invited artists may waive the jury fee, but new images must be submitted. Participation in previous shows does not guarantee acceptance.

## ACCEPTANCE OF WORK

Solely by jury from digital images on CD. Depicted work must be current and representative of the work to be brought to the show. Jurors look for work that is well conceived and executed, and that exhibits imagination and originality. All items displayed at the show must be the artist's own original, handcrafted work and the artist must be present in the booth.

- Apply online at TylerParkArts.org under Crafts in the Meadow. Submit images according to directions or send a CD with 3-5 images per medium with **one booth image** (JPEG 300 dpi).
- Label each with artist's name, medium, and title.
- Images should show one item clearly against a simple background.
- Artists who wish to share a booth with others must enter individually.
- Anyone misrepresenting entries or breaking any rule during the show may be asked to leave. No refunds will be issued.
- Selection of exhibitors remains the exclusive right of Tyler Park Center for the Arts and the results are final. Jurors reserve the right to limit categories and reject work deemed unsuitable.
- **Rolling notifications begin in March.**

## ARTIST APPLICATION

- Artists are responsible for the setup and removal of their own displays, furnishings, and trash.
- All sales will be transacted directly between the artist and the buyer.
- The show will take place rain or shine.
- Live music, performing arts, and other entertainment will take place throughout the weekend.
- Great food will be available from well known food vendors.
